#### ESSENTIAL QUALIFICATIONS: PROFESSOR (Obstetrics and Gynaecology)

- (i) A basic University or equivalent qualification included in any one of the Schedules of the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register;
- (ii) M.D. (Obstetrics and Gynaecology)/ M.S. (Obstetrics and Gynaecology) from a recognized University/Institution or equivalent.
- (iii) Ten year's experience in the profession after acquiring postgraduate qualification, out of which four year's should be as Reader/Associate Professor in a Recognized Medical College/Teaching Institution.

#### Desirable:

Minimum four research publications indexed in Index Medicus/National Journals and one Research Publication in International Journals.

II.

The Departmental Officer in the grade of Reader (Obstetrics and Gynaecology) with two years regular service in the grade will also be considered alongwith outsiders, and in case

he/she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

The Departmental Officer in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation/contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government, shall ordinarily not exceed five years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.
