

Senior Resident, CMO (General Medicine & General Surgery), Resident Anaesthetist & Resident Pathologist	Postgraduate Medical Degree i.e. (M.D./M.S./DNB/M.Ch./D.M) OR equivalent in the concerned specialty (recognized by MCI and registered either with Medical Council of India or State Medical Council).  <b>Candidates who have completed three years tenure of Senior Residency are not eligible for the post of Sr. Resident.</b>

Pay and allowances	<b><u>The Senior Residents, CMO (General Medicine &amp; General Surgery), Resident Anesthetist &amp; Resident Pathologist</u></b> holding PG Degree will be paid emoluments in the pay scale of Rs. 67,700/- (minimum pay 1 <sup>st</sup> Cell of Level-11) as mentioned in the schedule Part A of Pay matrix + NPA @ 20% as per Central Government Services (R. Pay) Rules 2016.

#### 1. TENURE OF THE POSTS

The posts of Senior Residents, CMO (General Medicine & General Surgery), Resident Anesthetist & Resident Pathologist are tenure posts and the appointments will be made for the **period of 44 days or may be extendable**, only as per the recommendation of the Selection Committee, **as per requirement or till the regular incumbent joins through regular selections, whichever is earlier**, subject to the condition that in case his/her work and conduct does not found satisfactory at any stage, his/her services shall be terminated without assigning any reason.

Further Senior Residency, if done, in any Central Institution/Hospital under the Central Residency Scheme, the same shall be counted while working out the tenure of three years (including previous experience), so as the maximum period of Senior Residency does not exceed three years.

#### 2. UPPER AGE LIMIT AS ON 01.06.2026

**FOR SENIOR RESIDENTS, CMO (GENERAL MEDICINE & GENERAL SURGERY), RESIDENT ANAESTHETIST & RESIDENT PATHOLOGIST:**

- Upper age limit as on 01.06.2026 - 45 years
- Relaxation in age for 5 years in case of Govt. Servants applied through proper channel
- Relaxation in age for 10 years in case of widows/deserted women and women judicially separated from their Husbands, who are not remarried.

#### 3. PAY SCALES:

- The Senior Residents, CMO (General Medicine & General Surgery), Resident Anesthetist & Resident Pathologist will be paid emoluments in the pay scale of Rs. 67,700/- (minimum pay 1<sup>st</sup> Cell of Level-11) as mentioned in the schedule Part A of Pay matrix + NPA @ 20% as per Central Government Services (R. Pay) Rules 2016.

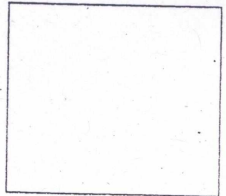
